# Policy: Greetings All,

As Policy Chairperson, one of my duties, as directed by the SENANA ASC guidelines is "To help keep things simple and avoid difficult situations regarding policy questions and issues." In following this direction I provide the following information.

1. It has always been the position of the current ASC Chairperson that our ASC must

- conduct business under the current Robert's Rules of Order.
- 2. This position has lead the current Chairperson to take actions, make rulings and restrict the conduct of various members of the ASC.

Those actions, rulings, restrictions and conduct will not be addressed here; however the fact of the incorrect basis for them will be.

That said. I refer to the first page of the handout you received labeled page 104. In the first paragraph you will see these words;"...your committee may wish to make a blanket decision to accept these rules as authoritative." Our ASC has not as of this time, made any such decision.

There are only five (5) references to Robert's Rules of Order in the A Guide to Local Services and they appear only in the pages I have included in the handout.

Based on those facts, my consultation with previous ASC Policy Chairpersons & subcommittee members. I make the following recommendation;

From this point forward, any actions, rulings, or conduct by members of the SENANA ASC which are claimed to be based on Robert's Rules of Order be considered "Out of Order" and only the current SENANA Service Guidelines be used to conduct ASC business.

There is one other, or many actually, the ASC body could take with regard to this issue. That being, "make a blanket decision to accept these rules as authoritative." "These rules" being those contained in the handout labeled "Sample Rules of Order".

There are points that beg to be made notwithstanding, with regard to making such a decision;

- 1. Some of the "sample rules" contradict what our current ASC guidelines state.
- 2. Regarding issues that are not specifically addressed by the "sample rules" the ASC would be directed to consult Robert's Rules of Order and act accordingly.

In closing let me say this; over the past 10+ years the functioning of our ASC has been for the most part uneventful. It has though, seen several 'bumps in the road' if you will, regarding procedural conduct. It is my position that using the current SENANA Service Guidelines to base our ASC conduct on will afford us a much 'smoother ride' along the service road we travel. In trusted service, John R.
