Bekka-As an H&I subcommittee, we love to go into all the institutions we are asked to go into, but it is a matter of manpower right now. I just wanted to let you know I don't know if it's going to work right now unless more people get involved. Discussion continued regarding what area the institution is part of. Jon-Because PI will be the first to reach out to them (institution,) we can also reach out to other possible areas and other resources available. There are other facilities on our radar, but we just can't commit. That is the worst thing we could do, would be commit to a facility and then call them 3 times out of 4 to cancel because we don't have the people.
- ❖ Boxes of stuff from Berean: Sam-The church called and said there were 2 boxes left behind; They are now in my car. There are old secretary notes and treas reports that are over a decade ago. I believe this is stuff that came from the unity. There is a set of posters, some things that may have belonged to activities at one time, some coin rolls, stampers, misc tags. Jon-There is an executive committee member that is charged with maintaining the area archives. It is the vice chair's responsibility to maintain records and files of that nature. As the chairperson in the absence of a vice chair, I would be willing to take that stuff off of Sam's hands. Group discussed potential for storing records digitally as well as making a detailed inventory of the items.
