S.E.N.A.N.A. Activities Committee Guidelines Revised 09/2018

ARTICLE 1

NAME

The name of this committee shall be the Southeast Nebraska Area Narcotics Anonymous Activities Committee (referred to as SENANAAC) and shall meet as designated by activities Committee Chairperson.

ARTICLE 2

PURPOSE

To provide and maintain an atmosphere of recovery and unity throughout the fellowship of Narcotics Anonymous, while providing celebrations of recovery.

ARTICLE 3

DUTIES

1. To serve the Southeast Nebraska ASC.
2. Keep an updated inventory of supplies.
3. Schedule functions with minimal conflicts with other NA activities.
4. Submit yearly a tentative schedule of events to the ASC for approval.
5. Make and distribute flyers in a timely manner.
6. Annual functions to include:
 - A. Hold one Learning Day per year.
 - B. Hold a NRCNA fund-raiser.

ARTICLE 4

FORMAT

1. Open meetings with Serenity Prayer.
2. Reading of Narcotics Anonymous 12 Traditions and 12 Concepts
3. Roll call of all present. (Establish voting members.)
4. Review and approval of previous minutes.
5. Review and approval of Treasurer's report.
6. Old business.
7. Open floor.
8. New business/Dates of next 2 meetings.
9. Close the meeting.

ARTICLE 5

MEMBERS

General membership shall be open to all NA members of continuous clean time who choose to participate.

Voting members are limited to individuals that attend 2 consecutive activities meetings within the last 6 months, with the exception of the Chair.

ARTICLE 6

OFFICERS

1. The officers of SENANAAC shall be the Chairperson, Vice Chairperson, Secretary, and Treasurer. These officers shall perform the duties as prescribed by SENANAAC guidelines, position descriptions, and any other duties assigned by SENANAAC or the SENANA ASC.

2. If any officer of SENANAAC misses 3 consecutive meetings they will be automatically removed from their position

ARTICLE 7

QUALIFICATIONS AND DUTIES OF OFFICERS

1. Chairperson

Qualifications:

One year continuous clean time and 6 months service experience at the Southeast Nebraska area level. This position is a 2 year commitment.

Duties:

- A. Preside at all SENANAAC meetings
- B. Provide an agenda for the SENANAAC meetings.
- C. Be a co-signer of SENANAAC bank account if not a financial conflict of interest.
- D. Delegate responsibility to committee members.
- E. Attend the Southeast Nebraska ASE and make monthly report.
- F. Set the time and location of the next 2 meetings.
- G. Keep archives, guidelines, minutes, agendas, and any related materials.

2. Vice Chairperson:

Qualifications:

Six months continuous clean time. This position is a 1 year commitment.

Duties:

- A. Inventory after functions.
- B. Prepare supplies for following event.
- C. Perform the duties of the chairperson in their absence.
- D. Be a cosigner of the SENANAAC bank account.

3. Secretary

Qualifications:

Six months continuous clean time. This position is a 1 year commitment.

Duties:

- A. Record and distribute minutes of each SENANAAC meeting.

4. Treasure

Qualifications:

One year continuous clean time. Minimum of 6 months group treasure experience. This position is a 1 year commitment.

Duties:

- A. Must balance account monthly with bank statement.
- B. Disburses any funds with the approval of the committee (disbursements must have attached receipts.)
- C. Be a co-signer of the SENANAAC bank account.
- D. Properly prepare a financial statement to be included in the monthly report to Southeast Nebraska ASC.
- E. Properly prepare a financial statement at the end of each calendar year.

5. Flyer Person

Qualifications:

Six months continuous clean time. This position is a 1 year commitment.

Duties:

- A. Create flyers for upcoming events
- B. Make flyers available to groups via ASC, webmaster, and activities fb page.

ARTICLE 8

ELECTION OF OFFICERS

1. Committee Chairperson will be nominated and elected as specified in the Southeast Nebraska ASC guidelines for the nomination and election of subcommittee chairs.
2. All other committee officers will be nominated and elected from voting members of SENANAAC.

ARTICLE 9

VOTING

1. Voting members will be any member of NA, which attends 2 consecutive SENANAAC meetings within the last 6 months.
2. Any member of Narcotics Anonymous may make a motion or participate in committee discussions. Motions must be seconded by a voting member.
3. Motions may be amended by any member or withdrawn by the maker any time prior to voting. An amended motion must be re-seconded.
4. Motions will be passed by simple majority.

ARTICLE 10

OPERATING BUDGET

The operating budget for SENANAAC will be \$400.00. Any funds over this amount will be donated to Southeast Nebraska ASC, unless previously designated.

ARTICLE 11

SPIRITUAL GUIDANCE

1. The Twelve Traditions of Narcotics Anonymous.
2. The Twelve Concepts of Narcotics Anonymous.
3. The Southeast Nebraska ASC guidelines.
4. The current publication of the guide to Local Services in Narcotics Anonymous.
5. Current publications of all pertinent NA handbooks.

ARTICLE 12

AMENDMENTS TO GUIDELINES

Any voting member may propose an amendment to these guidelines at a regular SENANAAC meeting. The proposal must be seconded and voted on by members attending the SENANAAC meeting. Note, a simple majority vote is necessary to amend.

The amendment shall go into effect upon approval of the ASC

- ❖ **Motion #2: <<VOTE IN GROUPS>> Change policy VI FINANCES; 6 To read: The Chair, Vice Chair, Treasurer and Secretary will be the only signers for the ASC bank account. Every check written shall contain 2 signatures. Ensuring the checks contain 2 signatures will be the responsibility of the signers as well as the audit ad-hoc committees and not the responsibility of the financial institution.** Intent: To be in compliance with our policy and not have to spend time, money or resources in search of other banks.

Financial Impact: Possible saving on fees Change in Policy: Yes

Discussion: David- It came to light that we are not in compliance with our policy as its written because the bank we are currently with does not actually have a 2-signature option. They told us they did, turns out they don't. Jon looked around and found some with fees. To keep continuity of our records what we can do is change our guidelines so we can be in compliance with them. Amber- People I've spoken with seem to like the bank that we use so I figure why spend more money and change banks. Sam-Just clarify, what you're saying is make it our responsibility that we have 2 signatures on it rather than finding a bank to monitor that for us. Making sure we are accountable to ourselves. David- Yes. Jenny- Is this applicable just to the area? David- For this motion, yes. Shellie- So Jeff then would just need to make sure there are 2 signatures before a check goes out. David- Yes. There are 4 possible signers per our policy: Chair, Vice Chair, Treasurer and Secretary. And when the audit committee is put together this will be looked at. This way we have additional checks and balances.

- ❖ **Motion #3:** <<VOTE IN GROUPS>> **Change policy VIII SUBCOMMITTEES; 6; a) To read: The H&I, PI, Activities, and Literature Subcommittees may have a checking account for the operation of financial expenditures. The Chair, Vice Chair, Treasurer, and Secretary of the committees will be the only signers for the account. Checks written shall contain 2 signatures. Ensuring the checks contain 2 signatures will be the responsibility of that subcommittee as well as the audit ad-hoc committees and not the responsibility of the financial institution.** Intent: To be in compliance with our policy and not have to spend time, money or resources in search of other banks.

Discussion: David- This is the same as motion 2 only it applies to the subcommittees, the subcommittee being responsible as well as the audit ad-hoc committees.

- **Strike from policy VII; 2; f) thus changing line g) to line f) and line h) to line g).**
 - **Change policy VII; 4; i) To read: Maintains ASC Post Office Box and is on PO Box registration card. Holder 1 of the 2 keys and responsible for picking up mail prior to ASC.**
 - **Change policy VII; 5; h): “Vice Chair” replaced with “Treasurer”**

Intent: To give the duty to an active executive committee member as we have not had a Vice Chair recently. The Treasurer makes sense in order to have bank statements for reconciliation of the account prior to the ASC meeting.

Financial Impact: None Change in Policy: Yes

Discussion: Jon-Current policy is Vice Chair and the RCM are the key holders. We haven't had vice chair in a very long time. This motion will shift the primary holder and controller of the PO box key from the vice chair to the treasurer. It will be the treasurer's and then the RCM's responsibility to get the mail. Added benefit- There's a line item for statement balance on the treasure's report. The treasurer doesn't always have the bank statement prior to today. If the treasurer is now picking up the mail, he would then be able to add one more reconciliation number, or check and balance, to the report by being able to add our statement balance. David- I think it just makes sense that the person who needs the checks and statements to reconcile the bank account should be one able to get the mail. This would give Jeff the ability to fill out that line item and see if there are checks that haven't been cashed yet. Sam- I think it's a great idea. To Jeff, is this something you will be willing and have time to do? Jeff- Yes. Is there a day of the month that mail has been getting picked up? Jon- The day before area was a common practice.

- ❖ **Motion #5:** <<VOTE IN GROUPS>> **Add to policy section VII, subsection 4, letter K (Treasurer) will be the contact person between the facility where our monthly ASC meetings are held. Will also schedule and reschedule all meetings with the facility with as much notice as possible to the facility.** Intent: To have one point of accountability and reduce any scheduling conflicts that may occur.

Discussion: Chad- Our contact person used to be someone that attended area, that person has since left. This gives responsibility to a position rather than just an individual. This was mainly because today no one had told them we changed our meeting from the 1st Sunday to the 2nd Sunday. Jeff- So the motion is to make the treasurer responsible for setting up the time and place and rescheduling? Chad- Yes.
