There were some open floor discussions. There was discussion concerning how to proceed with defining the parameters of CBDM and creating a policy surrounding it. In addition there was talk about formatting the entire regional policy to allow it to be easier to access and understand. We discussed the website to see the pros and cons of putting every activity in the

entire N.A. on our website. Finally, we received clarification as to the time frame that the secretary must have the minutes distributed within.

Region has now shifted to CBDM. Basically that means you will no longer see the word "Motion". Instead you will see the word "Proposal" where areas are asked to vote. With that being said there will be, hopefully at the end of this report or next month, a list several proposals will need your discussion & votes.
