I hope you are all doing well. Currently, the NRSCNA 37 Convention Committee has come to the decision that we will need to postpone the convention. There are some health restrictions placed on the hotel that would only allow 150 people in the main room, and 8 people in the smaller rooms. The hospitality room would not be able to serve to allow our members to socialize, no dance floor or people congregating, and the 6 ft social distancing would apply, meaning that chairs would have to be set up theatre style for spacing. A new contract has been provided by the hotel. Terms are provided in a new contract with a date set for October 1st - 3rd of 2021 and has been included in this email.
