MOTION PASSES

Topic 1: Clarification of activities and literature budgets that were submitted - Happy Havelock would like to know what the intent is for submitting said budgets. Lori would like to know why the activities committee has a NRCNA fundraiser listed as an expense. Lori C. stated if these budgets are informational, we do not need to vote. Kimberly R. asked where the budget ledger form came from and stated that subcommittees should not be paying rent each month/listing it as an expense if they are not meeting every month. Josh H. informed the area that the form was created, in addition to a monthly ledger form and policy to standardize financial reporting to the ASC. The rent paid is due to the "cubby" we rent out for storage to Eastridge Presbyterian church. Members from the literature committee stated they meet each month before the ASC, and a suggestion was made to change the verbiage around the term "rent" to "storage." The activities subcommittee brought up that it is difficult for them to comprise a more accurate budget because they often can't project what they are going to bring in at each event. Doris K. offered to bring a more accurate literature budget to the next ASC. The activities subcommittee will meet at the library for the remainder of the year to save on having to pay rent/including a rent expense in their budget.
