Greetings in recovery! Seth and I attended the Regional Service committee that was held here in Lincoln. So much information so I will just hit the highlights. If you would like more complete information, please refer to the minutes on the regional website. The new meeting finder is live and running on na.org! Please check this out, they did an excellent job in making this tool easy to access.

New Meeting Finder → (<u>www.na.org/meetingsearch</u>)

We attended the subcommittee meeting for information on the phone line. Thank you for all the input. They will be using our feedback to fine tune the process.

Advantages of a regional phone line to our area include:

- No cost to move local numbers into the system.
- You can keep your local phone line if you choose to.
- Extremely low cost to the region.
- Areas would no longer need to pay for their phone line.
- Increases the trusted servant resource pool.
- Ease of system use and data collection available.

The way this will work is: The addict calls the number, and they will be directed to a couple of options. Example: "Press 1 to find a meeting within your 40-mile radius in Nebraska. Press 2 to speak to a live addict. Press 3 to be directed to a list of emergency numbers. (911 etc.)" The goal is to get the addict to a meeting. The timeline is to have this up and running this year. There will be a 2-phase launch starting in June for PR week and will be a text only version. The training will consist of training the trainer workshops and phone line volunteers in the area. They hope to have the live addict option available in September in time for the NRCNA convention. They need willing volunteers to be part of the phone line scheduling when someone wants to talk to a live addict to find a meeting. They are also looking for a phone line coordinator, which will be a brand-new position. As an area, we will be reaching out to schedule our training, hopefully sooner rather than later. PR folks, please get with me for more info. This will be a huge savings for us as we will be able to retire the current phone line! (Please see the following attached report regarding the Nebraska Phone Line from Barry B.) Greetings in recovery, The phone line is ready for testing. We have been approved to use the text feature. The number is 844-818-3733. You can text a zip code to the number or call the number and follow the prompts. Please test the number and remember that we only have meeting information and voice mail available currently. If you chose the county feature, you must say county in the name. Example "Hall County." We would like to turn this live during PR Week that is one month away, so we are short on time for

testing. If you find a problem or it does something you do not expect please fill out this form. Here is the link.
